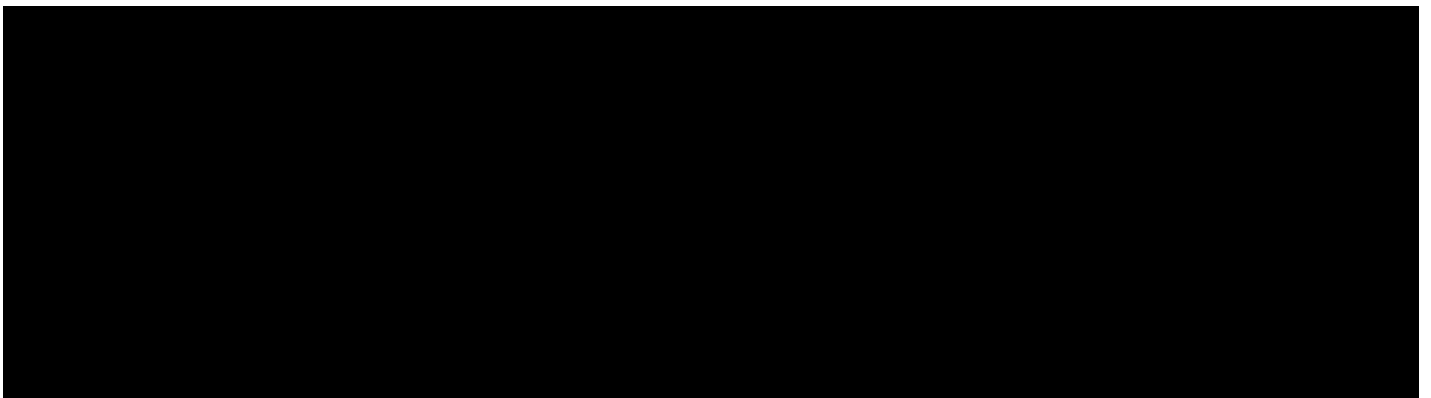
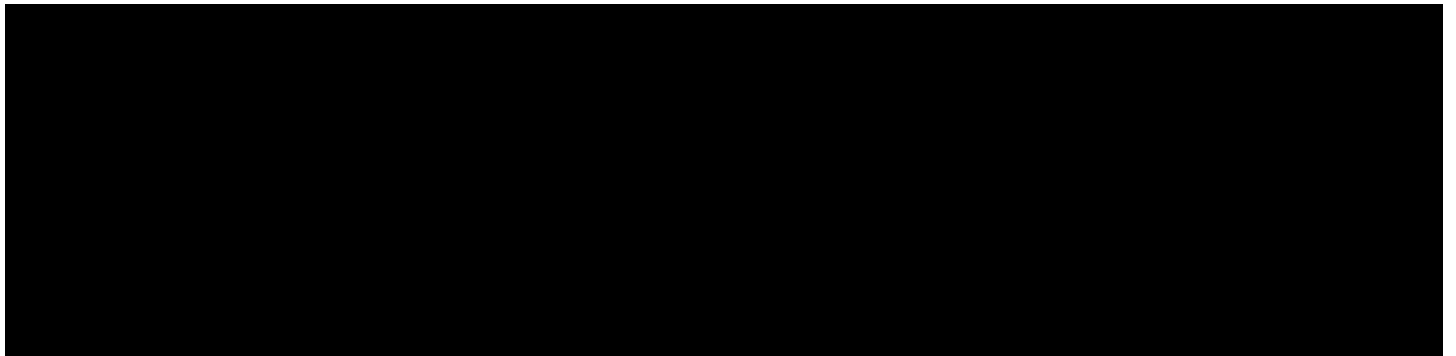

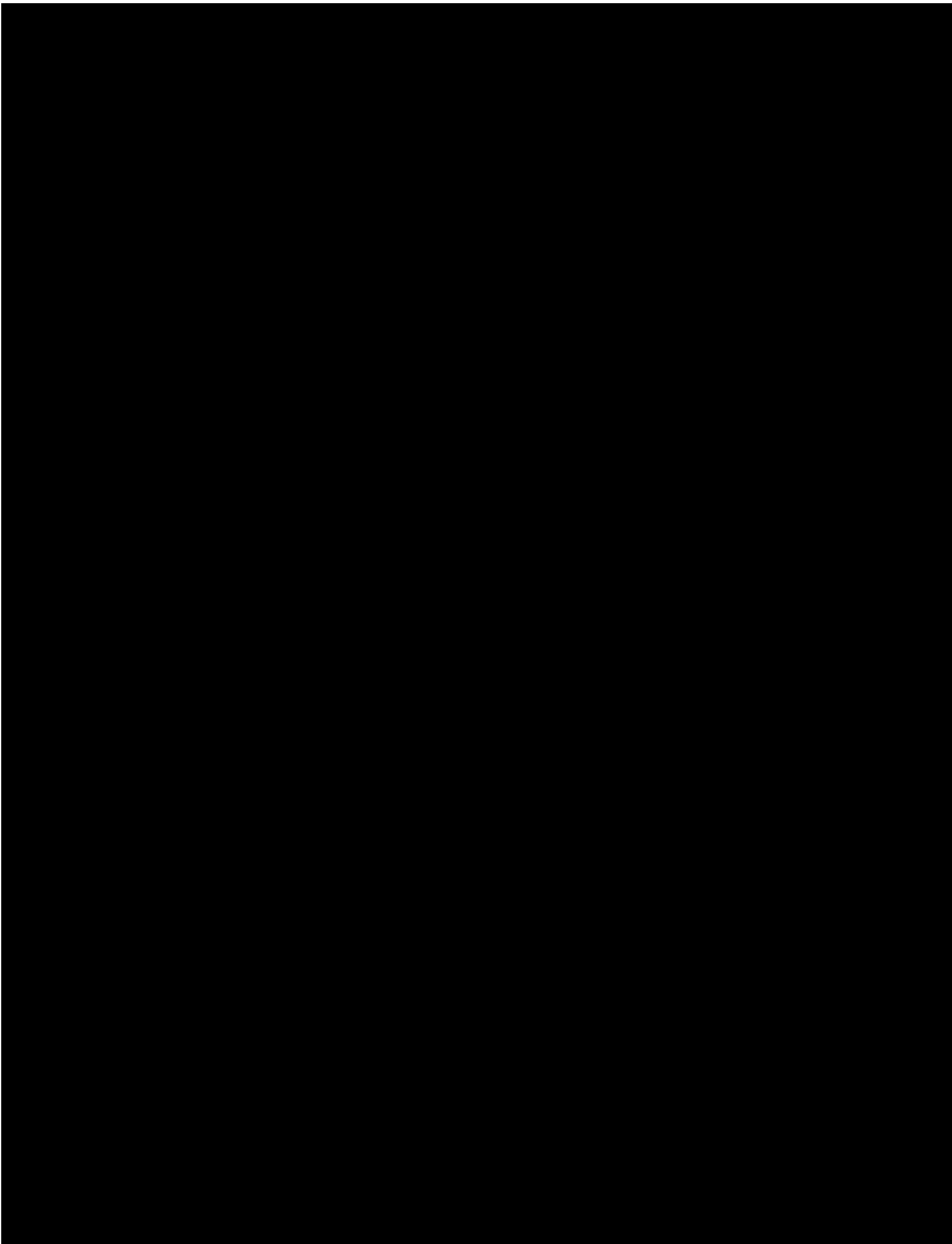
Mr. DeWuske,

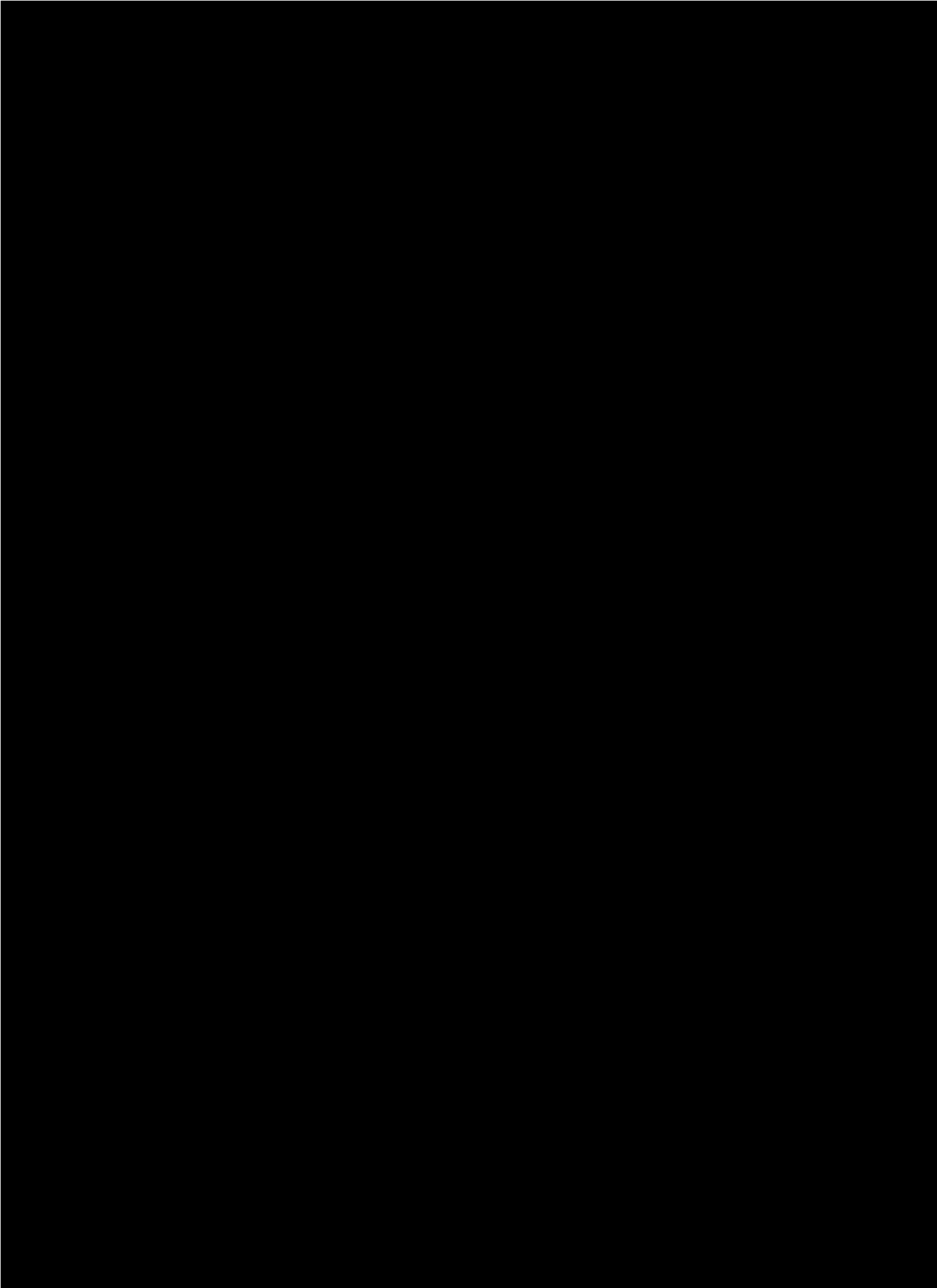
